- title, name, surname, date of birth, contact details, information about work experience, education, completed training, skills, abilities, and hobbies, including driving license information, information about previous and current employers, job positions, or whether the data subject is unemployed;
- information about the job position applied for within the company;
- information provided during the verification of references from previous employers (if consent is granted);
- other data provided to the company by the data subject during the personal interview or through other means.

SOURCES OF PERSONAL DATA:

Personal data is obtained directly from the data subject or from third parties based on the data subject's consent. Verification of the accuracy of provided references regarding previous work experience and employment is conducted by contacting previous employers.

PROFILING OF NATURAL PERSONS:
