LEGAL BASIS FOR PROCESSING:

Non-targeted B2B sales and marketing communication is primarily conducted by sending information e-mails. If the company also has additional contact information, sales and marketing communication can also be conducted by phone or other available methods (e.g. sending information sheets or short electronic messages, etc.).

The disclosure of personal data by the data subject is voluntary. <u>The data subject has the right to withdraw</u> <u>their consent at any time</u>. The withdrawal of consent shall not affect the legality of the processing of personal data, which was based on the consent granted, and which was conducted before its withdrawal. If the data subject does not grant their consent, their personal data will not be processed for the purpose of non-targeted B2B sales and marketing communication and no sales and marketing information will be sent.

THE SCOPE OF DATA PROCESSING:

As part of the above purpose, common personal data will be processed, such as: name, surname, contact data (address, e-mail, telephone number, etc.).

SOURCES OF PERSONAL DATA:

- **file a complaint with a supervisory authority**, especially in the Member State of their habitual residence, place of work or place of alleged violation, as well as the **right to an effective judicial remedy** if they believe that the processing of their personal data is in violation of legal regulations;
